Telephone Entries and Unsigned Entries Cannot Be Accepted. Entries Not On Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.

Entries received without fees will not be accepted. Acknowledgement of entries will be made as soon as practical after closing via mail or email. Should acknowledgement not be received by the exhibitor within a reasonable time, please notify the event secretary

**ENTRY FEES Separate Fee for Each Dog, Each Trial**

**NOTE:** When a dog is entered in more than one class, the highest price class is considered the first entry. A Recording Fee of 50 cents for each dog and an AKC Event Service Fee of \$3.00 will be required for each recordable single entry class at any Licensed or Member Club Show or Obedience Trial. (American Kennel Club Rule, Chapter 11, Section 2). A \$3.50 AKC Recording Fee will be required for the first entry in Rally and \$3.00 for each additional entry in Rally. (American Kennel Club Rally Regulation, Chapter 1, Section 5). These Fees are paid to the American Kennel Club.

FIRST ENTRY of each Dog (Obedience & Rally) . . . . . \$30.00

EACH ADDITIONAL ENTRY of the same dog . . . . . \$24.00

Exhibitors should follow their veterinarian’s recommendation to assure their dogs are free of internal and external parasites, communicable diseases, and have appropriate vaccinations.

## ATTENTION EXHIBITORS

### No set-ups allowed the night before the show

•**DIRECTIONS TO TRIAL SITE:** Take 118 Fwy. to “Tapo Canyon Rd.” Exit, Then: AUTOS: Proceed 1 mile to “Avenida Simi” (there is no light at “Avenida Simi”). Turn Left (West) and proceed 1/2 mile to Park/Parking is on Left. •Directions to RV parking. Take 118 Ronald Reagan Fwy. To Simi Valley. Take “Tapo Canyon Rd.” Exit, Proceed 1/2 mile to light at “Alamo Ave.”. Turn Left (West) and go 1/4 mile. Turn Right into DVM lot and drive past that to Park. Parking on left side near back of Simi Courthouse.

•**ELECTRONIC PREMIUM LIST NOTIFICATION** If you would like to receive an electronic copy (e-mail) of the Premium List in the future, LEGIBLY write your email address on the entry form and check the box.

•**TRANSFERS** will be allowed at this trial. Dogs which according to their owners' records have earned an obedience or rally title after the closing of entries for the show may be moved up to the next class, provided this transfer is made in writing and presented to the Secretary at least 30 minutes prior to the start of each trial.

•**BITCHES IN SEASON** Refund of entry fees for bitches entered in obedience/rally who come in season after the closing date of this show may be obtained by sending a veterinarian's certificate to the Show Secretary. This certificate must be postmarked before the opening date of the show or given to the Show Secretary one half hour prior to the start of the first class in the trial. The sum of \$12.00 for the first class entered and \$7.00 for further classes entered, will be returned to the exhibitor.

•Exhibitors are advised to make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany the premium list. Rule books may be obtained from A.K.C., online at [www.akc.org](http://www.akc.org)

•It is distinctly understood that every dog at this show is in the care and custody and control of his owner or handler during the entire time the dog is on the show premises.

•Declination of Entries. The Club may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against the Kennel Club or any official thereof.

•If, because of riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry will be made.

•Do not leave any dogs in closed vehicles. All persons attending this dog show hereby waive any claim for damages against the Buenaventura Dog Training Club, Inc, its members or agents, in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.

•There shall be no drilling nor intensive or corrective training of dogs on the show grounds or premises.

•All dogs shall be kept on leash except when in the obedience or exercising ring or confined in crates.

•The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is distinctly understood that exhibitors will exercise control and restraint over their children on the day of the show.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. **INSTRUCTIONS 1.** (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
